

### **Cameron County, Pennsylvania Community Profile**

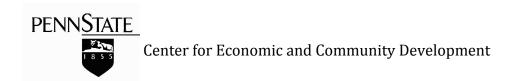
Demographic, Educational, and Industrial Breakdown

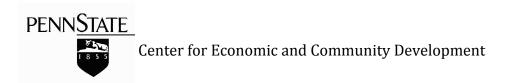

## **Table 3. Hispanic or Latino Breakdown, 2010 Census**

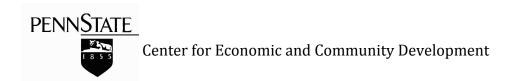
Hispanic or Latino community members have further distinction within the census information due to the diversity within the Hispanic and Latino communities.

### **Table 4. Living Relationships, 2010 Census**

Living relationships refer to how the population in a community lives amongst each other. These groups are divided amongst those in households, those that are institutionalized, and those that are non-institutionalized. Those institutionalized refer to those that are in an institution of sorts, such as a prison or old age home. Non-institutionalized population refers to those that are neither in a household nor in an institution.

Housing occupancy refers to the number of people in given types of housing as well as the state of the housing unit on the market.

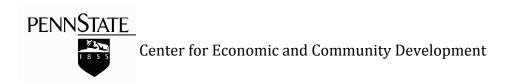

Housing tenure refers to the breakdown of housing units by those who own their housing units and those who rent.

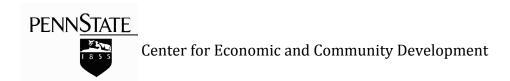

## Table 8. Employment by industry, 2012 American Community Survey

The population breakdown by industry separates all those in the working population, 16 years and above, into the industry they currently work in. The Census Bureau uses a consistent methodology to determine the industry classifications into which employees are assigned across the country. Those that are unable to release information due to disclosure complications are due to the low numbers of industries in that sector, and potential for breaching privacy.
